I \_\_\_\_\_ agree to update dispatch as soon as I become available, provide any updates if/as needed, such as CONFIRMING PICKUP ADDRESS, WHEN ARRIVING ONSIT TO PICKUP, WHEN LOADED, PROVIDING ALL UPDATES AS DISPATCHED, WHEN ARRIVED AT DELIVERY, AND LASTLY, PROVIDING A SIGNED POD/BOL WHEN DELIVERED.

I \_\_\_\_\_ understand for any missed update, there will be a \$100.00 deduction per update.

I will provide a Certificate of Insurance listing *RP EXPEDITING LLC / DBA: RPGL* as an additional insured in a timely manner upon submitting all paperwork via US MAIL.

I agree that *RP EXPEDITING LLC / DBA: RPGL* may release me from their active truck list any time for not fulfilling the requirements of all verbal/nonverbal agreements.
